A number of issues were raised by numerous members of the committee concerning the progress of the organisation of this event and after lengthy discussion the proposal was formulated that the tournament organisation would be formally handed to a subgroup committee consisting of Tom Bedkowski, Claire McIntosh and Marnie Wills. This proposal was carried unanimously. TB will take the lead in tournament organisation and competition structure, CM to be responsible for coordination of regional coaches and selectors seeing players. Other people will feed into this sub group as and when necessary to advise on eg playing schedule and demands (DW) and Referees requirements (SG).

# 9. RFU and RFL update

The ETA is currently in discussion with the RFU over various aspects of Touch development and league affiliation. Negotiations are at an early stage and further information will be shared when appropriate. A working party consisting of highly qualified coaches and administrators within the ETA has been formed and will report back in the near future.

# 10. AOB

**Lesley McCallion** raised concerns re Regional Boundaries (specifically the split of NE and Cumbria = NE; NW and Yorkshire = NW) and also the impact that the current ETA stance on affiliation has on the NE region in particular. It was decided that a review of regional boundaries will take place following the Nationals competitions this year especially with regards to regions that are struggling for players. The current ETA stance that 'players who want to play regional or national representative Touch cannot take part (play, referee or organise) any non-affiliated Touch' was accepted as being a massive issue currently for the NE regional team. Due to the lack of availability of affiliated Touch opportunities within the region it was decided that for this season the NE region will be granted exemption from this policy. This will also be reviewed following this years competitions.

**Taryn Pile** raised the issue of Youth Development and would like each region to consider a Youth Development plan to include development days in the region and formation of youth teams. Chris Simon and CH to provide info on Sportivate funding (6 weeks of funding to provide sporting opportunities to 14-25 yrs age group).
