SUBJECT: VARIOUS URGENT MATTERS

May I wish you all the best in your preparations for the 2015 World Cup. The event is planned to be the biggest ever and Touch Football Australia and the Federation are working hard to ensure that all participants will have a unique and rewarding experience. There are a few very important matters that need to be addressed and I have taken the opportunity to list these below.

UNIFORM POLICY AND DEADLINE DATES:

Due to the fact that the presentation of Uniform Visuals is well overdue and there are still many participating nations that have not supplied these visuals it is becoming urgent as if there are uniform designs that are not acceptable it is getting far too late to redesign and supply prior to the World Cup.

If your nation is one that has not supplied the uniform design to FIT please take immediate action.

PAYMENT SCHEDULES:

Touch Football Australia (TFA) and the Federation of International Touch has set deadline dates for payments of fees and levies. It is imperative that these dates are adhered to. TFA are already investing in the pre- tournament program and require that competing nations meet the deadlines as set. It is now well passed the deadline for team Nomination fees, and now the Individual levies are overdue as well.

IT IS ABSOLUTELY ESSENTIAL THAT THE TEAM LEVIES ARE PAID BY FRIDAY 6TH FEBRUARY OR AGREEABLE FINANCIAL ARRAGEMENTS ARE MADE WITH TFA AND FIT. IF LEVIES ARE NOT RECEIVED OR AGREED ARRANGEMENTS MADE THEN THE DRAW WILL BE COMPLETED WITHOUT THOSE TEAMS. THESE TEAMS CAN BE READMITTED WITH A LATE FEE OF \$100 PER TEAM







It is understandable that individual payments are harder to gather together and pay however the host nation has financial commitments to meet and cannot do so with confidence without the individual payments being made.

IT IS ABSOLUTELY ESSENTIAL THAT THE INDIVIDUAL PAYMENTS ARE PAID BY THE END OF FEBRUARY OR AGREEABLE FINANCIAL ARRANGEMENTS ARE MADE WITH TFA AND FIT. IF LEVIES ARE NOT RECEIVED OR AGREED ARRANGEMENTS MADE THEN THE DRAW WILL BE COMPLETED WITHOUT THOSE TEAMS. THESE TEAMS CAN BE READMITTED WITH A LATE FEE OF \$100 PER TEAM

ELIGIBILTY POLICY AND DEADLINE DATES:

The Federation's Eligibility Committee has dealt with many eligibility and 2nd representation requests to date, and now wish to reinforce THAT the closing dates for both issues **HAVE BEEN AND GONE**. The committee will extend the closing date for both to **Friday 13th February 2015** please ensure all eligibility issues are lodged prior to this date.
