Role purpose:

- Continue to develop and implement the referee selection and subsidy eligibility documentation on behalf of England Touch;
- Work closely with the European Federation of Touch (EFT) and Federation of International Touch (FIT) around international events i.e. Euros, JTC, TWC, Permits, YTWC, Club Champs etc;
- Discuss any rule changes etc on the behalf of England Touch, in collaboration with the high level referee community and NRM.
- Work with the England Touch High Performance Team to assess opportunities to support England training camps.

Qualifications: Level 3 referee (or higher) is required.

Hours required: 1-2 per week off season, 2-3 per week during busier periods in the season

Locations: Work from home / tournament venues.

Contract type: One year term. Re-appointed yearly at the AGM.
